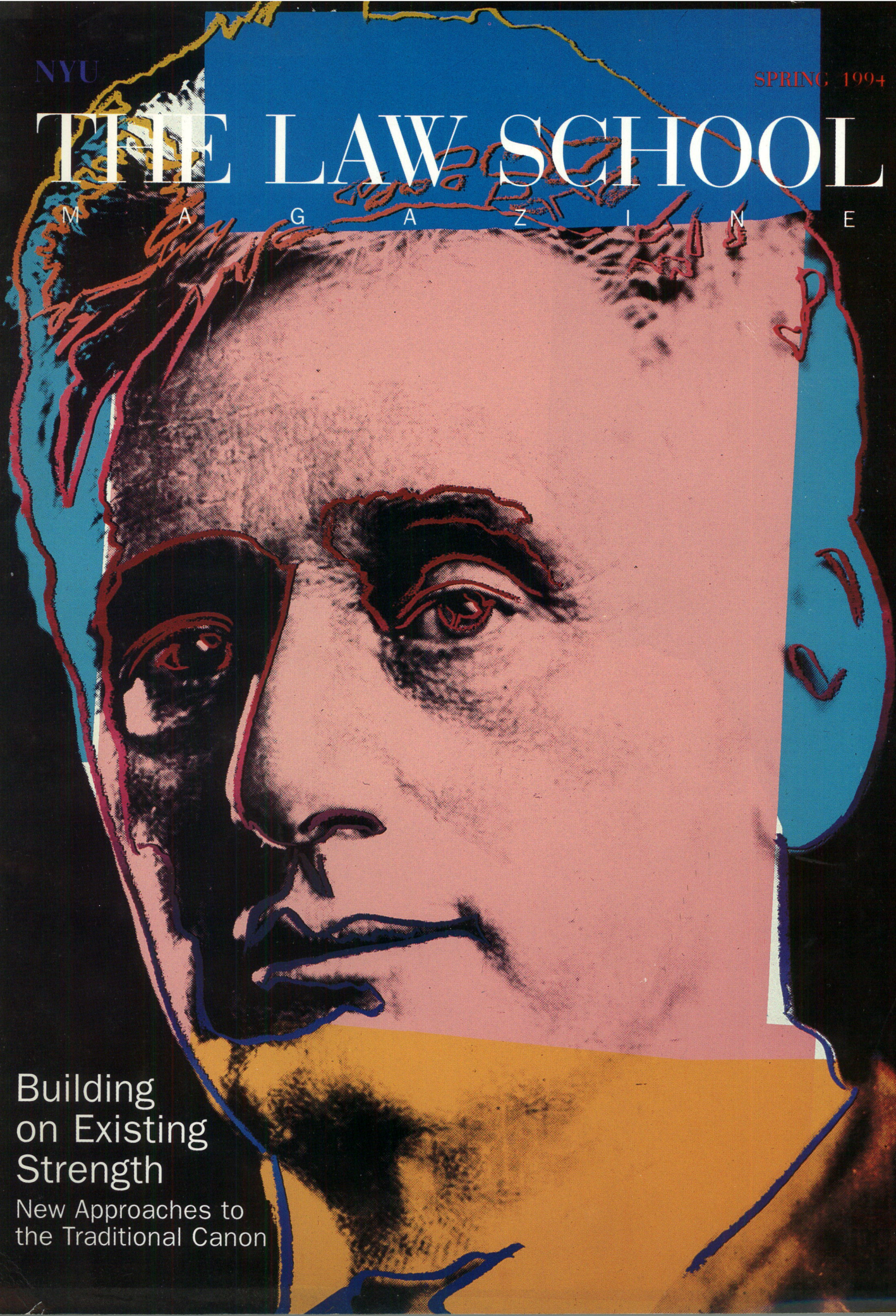

1957 from the Faculty of Law, Kyoto University, and for the next two years trained at the Legal Training and Research Institute, Supreme Court of Japan, after which he received the qualification of "Full Jurist." From 1962 to 1963, he did graduate work at the University of California at Berkeley and was awarded the LL.M. He then went on to earn a J.S.D. at Cornell Law School in 1964.

Professor Taniguchi has been a member of the Faculty of Law at Kyoto University since 1971. His other teaching experience includes visiting professorships at the University of Michigan Law School, the University of Aix-Marseille, the University of California at Berkeley Law School, Duke Law School, the University of Hong Kong, and Georgetown University Law Center.

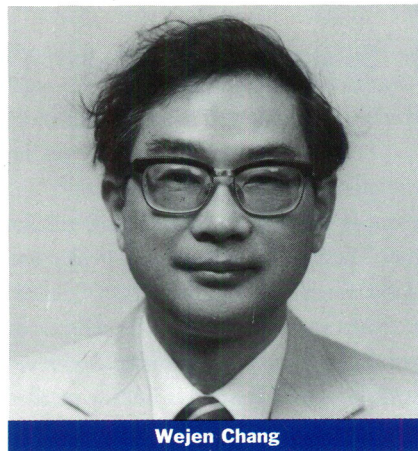
A prolific scholar, Professor Taniguchi has published many books and articles in Japanese on topics as varied as civil procedure, bankruptcy, the court system, legal education, the legal profession, comparative law and jurisprudence. Additionally, he has published more than 20 articles on similar subjects in English, both in this country and in Europe. His current professional affiliations include Chairman of the Kyoto Prefectural Labor Relation Commission and membership on the Law Revision Commission of the Ministry of Justice of Japan as well as membership in many international and domestic academic organizations, such as the International Association of Procedural Law.

Wejen Chang

The world's leading scholar of China's legal history, Professor Wejen Chang, will offer a set of courses on China at the Law School. Professor Chang is currently a Research

Fellow at the Institute of History and Philology of the Academia Sinica in Taiwan and Director of the Center on Chinese Legal History at the Academia. In addition, Professor Chang was, until recently, a Professor of Law at National Taiwan University, the major law faculty of Taiwan.

Professor Chang received an M.A. from National Taiwan University in 1962 and an M.C.L. from Southern Methodist University in 1963. He then

earned an LL.M. at Yale University (1965), an LL.B. at National Taiwan University (1968), and an S.J.D. at Harvard University (1988). He was a research associate at Harvard Law School from 1965 to 1968, and he has been a visiting professor at U.C.L.A. (History) and Harvard Law School.

Professor Chang's major publications include *Chung-kuo fa-chih-shih shu-mu*, a three-volume annotated bibliography of Chinese legal history (1976), *Ch'ing-tai fa-chih yen-chiu*, a three-volume study of the Ch'ing legal system (1983), and *Ming-ch'ing tang-an*, an astonishing 340 volumes of Ming and Ch'ing Archives (1991).

In the fall of 1992, Professor Chang came to the Law School to give an "Asia Hour" talk to NYU students, a presentation that was extremely well received. This spring, he is scheduled to give the prestigious Hu Shih Lectures at Cornell

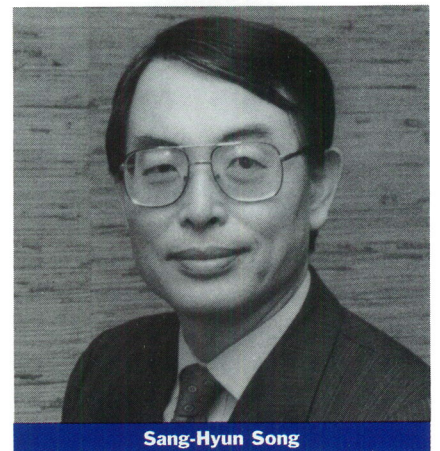
on the "Origins of Chinese Legal Thought."

Sang-Hyun Song

The world's foremost authority on Korean law and society, Professor Sang-Hyun Song of the Seoul National University in Korea, will offer a course on Law, Society, and the Legal System of Korea. Professor Song visited first in the winter of 1994 and received extremely high praise from colleagues and students for his knowledge, acumen, and teaching skills.

Professor Song received his LL.B. from Seoul National University in 1963, his LL.M. from Tulane University (Fulbright Fellow) in 1968, a Diploma from Cambridge University in 1969, and his S.J.D. from Cornell Law School in 1970. He has been a Humboldt Fellow at Hamburg University and an ACLS Fellow at Harvard Law School.

Professor Song was an attorney with Haight, Gardner, Poor & Havens of New York for two years and later a visiting lecturer at the University of Melbourne Law School. He has also been a visiting professor at Harvard Law School. In book form alone, he has half a dozen publications in English and Korean, including *A Comparative Study on Maritime Cargo Carrier's Liability under Anglo-American and French Laws*

(1970), *New Trends in Corporate Law* (1982), *Introduction to the Law and Legal System of Korea* (1983), and *The Korean Civil Procedure* (1993).

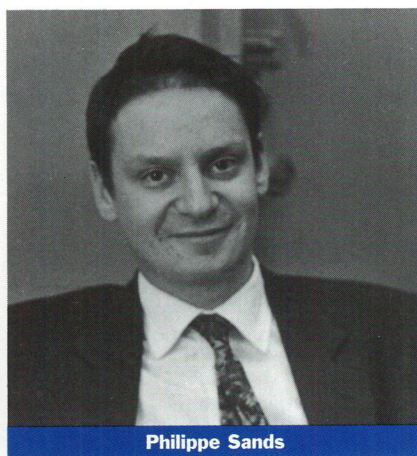
Professor Song has been a member of the Korean Bar since 1964, and he is president of the Korean Intellectual Property Research Society, Inc. and a member of the Advisory Committee to the Korean Supreme Court. He is also a member of the board of directors of the Korea Stock Exchange and an arbitrator for the International Center for Settlement of Investment Disputes of the World Bank.

Philippe Sands Joins NYU's Environmental Law Program

Professor Philippe Sands, the noted international authority on the environment and Director of the Foundation for International Environmental Law and Development, London University, has accepted a four-year visiting professorship at the Law School.

Since 1988, Sands has lectured at London University's Kings College, and now at the School of Oriental and African Studies. He lectures in public international law, EEC law, and international environmental law. Prior to joining the law faculty at London University, Sands was a Research Fellow in international law at St. Catharine's College of Cambridge University. During the academic year 1983 to 1984, he was a visiting scholar at Harvard Law School. He has also been a visiting professor at the Boston College Law School and a visiting lecturer at Tufts University.

In addition to his academic credentials, Sands has considerable professional experience. For several years, he has been a Tenant in the Chambers of R. Neville Thomas, QC at 3 Gray's Inn Place in London, where he has done advisory work to governments, non-governmental organizations, corporations and individuals on international and European environmental law, European community law, and public international law. He has represented clients and worked on cases before the English High Court, the European Court of Justice, the European Commission of Human Rights, the International Court of Justice, and the Iran-U.S. Claims Tribunal. Additionally, he currently serves as a special consultant on EC law

to the law firm of Milbank, Tweed, Hadley & McCloy of New York.

Sands was educated at Corpus Christi College of Cambridge University, where he was awarded a B.A. in Law (with Honours) in 1982 and an LL.M. (First Class) in International Law in 1983. His publications include *Chernobyl: Law and Communication*, a book of edited materials on transboundary nuclear air pollution (Grotius Publications, 1988), *Greening International Law* (Earthscan, 1993; New Press, 1994 U.S. edition), and two dozen or so articles, book reviews, and conference papers on a variety of topics. His four-volume textbook

and documents, *Principles of International Environmental Law*, will be published in September, 1994 by Manchester University Press.

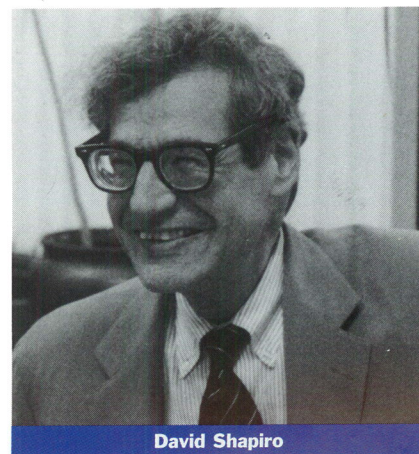
Nine Others Will Visit in 1994-1995

David Shapiro

David Shapiro, a leading authority on federal courts and the William Nelson Cromwell Professor of Law at Harvard Law School, will visit the NYU Law School for a semester in the spring of 1995.

Shapiro received his B.A. *magna cum laude* from Harvard College in 1954 and his LL.B. *summa cum laude* from Harvard Law School, where he was awarded the Fay Diploma and was note editor of the *Harvard Law Review*, in 1957. Shapiro then spent five years at Covington & Burling before clerking for Supreme Court Justice John Harlan. He has been a member of the faculty of Harvard Law School since 1963, and has been a visiting professor at the University of Pennsylvania and Stanford Law Schools.

From 1989 to 1991, Shapiro served as Deputy Solicitor General of the
